DESCRIPTION:

TURCO[®] DEFLOCCULATOR 2 is a powder compound formulated to degenerate accumulated paint residues in water-curtain spray booth systems.

TURCO[®] DEFLOCCULATOR 2 is non-corrosive to ferrous metal and copper alloys and helps retard rust formation on walls, sumps, baffles and pumps normally found in water-curtain booths. TURCO[®] DEFLOCCULATOR 2 effectively "kills" most paints upon contact.

BENEFITS:

TURCO[®] DEFLOCCULATOR 2 offers these benefits:

- 1. Non-flammable in concentrate or solution form
- 2. Readily dissolves in cold water.
- 3. Prevents paint build upon waterwall.
- 4. Works at very low concentrations.
- 5. Easy to control by simple titration.

USE INSTRUCTIONS:

<u>Preparation</u>: Paint booth, tank, curtain, spray nozzles and headers should be cleaned of old paint residues prior to introducing TURCO[®] DEFLOCCULATOR 2. Your HENKEL Territory Manager can recommend a suitable TURCO paint remover based upon the condition of your booth.

<u>Mixing</u>: Fill collecting pan with fresh, cold water to its operating level. Start pump and circulate water. Add TURCO[®] DEFLOCCULATOR 2 at the ratio of 2.5 g/L of water. Thoroughly mix solution.

<u>Note</u>: Never dump large quantities of TURCO[®] DEFLOCCULATOR 2 into water. Always add small amounts of product onto the top of agitated water, since heat is liberated and local pockets of steam may be formed.

DISPOSAL INFORMATION:

Dispose of spent solution per local, state and regional regulations. Refer to your local HENKEL Representative or HENKEL MATERIAL SAFETY DATA SHEET for additional disposal information.

CAUTION:

TURCO[®] DEFLOCCULATOR 2 contains sodium hydroxide, petroleum solvents, silicate and carbonate. Avoid contact with skin, eyes and clothing. Do not take internally. Use with adequate (equivalent to outdoor) ventilation.

Protective clothing, such as a chemical face shield or goggles and gloves, made from alkali resistant neoprene should be worn when using and handling this product.

Never dump large quantities of TURCO[®] DEFLOCCULATOR 2 in water. Always add small amounts of product onto the top of agitated water, since heat is liberated and local pockets of steam may be formed.

Hazardous carbon monoxide gas can form upon contact with food and beverage products in enclosed spaces and can be fatal. Follow appropriate tank entry procedure as recommended by Work Safe Australia.
