DESCRIPTION:

TURCO PRECHEK LF is a clean, colourless liquid formulated for precleaning surfaces prior to penetrant inspection.

TURCO PRECHEK LF also removes grease, pencil marks, ink marks, oil and grease from parts and is ideal for touch-up cleaning of parts prior to packaging where a quick, fast evaporative cleaner is desired.

TURCO PRECHEK LF should not be used on materials that are affected by aliphatic hydrocarbons.

As TURCO PRECHEK LF is highly flammable and must not be used where ignition is possible. For electrical applications WHITESOLV EC is recommended.

TURCO PRECHEK LF is currently listed in the latest QPL to Mil-C-25135 D and E.

USE INSTRUCTIONS:

Spray direct from the can until surface is clean. Do not spray without adequate ventilation. Ensure no ignition sources are present as PRECHEK LF is highly flammable.

Do not use TURCO PRECHEK LF near open flames, cutting torches or welding arcs, since material has a Pensky Marten flash point of -4°C.
